Florida House Bill 1365 and Senate Bill 1530: Unauthorized Public Camping and Sleeping

Recent legislation, Florida Senate Bill 1530 (SB1530) and Florida House Bill 1365 (HB1365), now Florida Statute 125.0231, has been passed and will go into effect on October 1st. This states:

- Municipalities and counties cannot authorize public camping or sleeping on public property without certification from the Department of Children and Families (DCF).
- Public sleeping / camping is:
 - Defined as lodging / residing outside:
 - In a temporary outdoor habitation used as living space, as evidenced by:
 - Use of a tent or temporary shelter;
 - Presence of pillows or blankets; or
 - Storage of personal belongings.
 - Without a tent or other shelter
 - Not defined as:
 - Sleeping overnight in a motor vehicle that is registered, insured, and located in a place where it may lawfully be.
 - Camping for recreational purposes on property designated for such purposes.
- If there is inadequate shelter space, municipalities may designate public camping locations on county or municipal property. This must:
 - Be approved by the county's and if applicable, municipal governing body;
 - Receive DCF certification;
 - Provide running water, restroom access, and security;
 - Not be in use for more than 365 consecutive days;
 - Be located in an area that is not zoned for residential use;
 - Be located in an area that will not negatively and significantly affect the property value or safety and security of other existing residential or commercial properties and would not negatively affect the safety of children;
 - Prohibit alcohol and drug use;
 - Provide behavioral health services, including substance use and metal health treatment resources;
 - Follow inspection and community posting requirements.
- Effective January 1, 2025, this law permits Pinellas residents and business owners to sue counties and municipalities for noncompliance.
- This may not apply during a state of emergency in this or neighboring counties.

Funding has not yet been officially allocated for this mandate, though some one-time funding may be provided through the State of Florida.

Florida Coalition to End Homelessness Statement Regarding FL HB1365 and SB1530 April 2024



In light of the signing of House Bill 1365 into law, and on behalf of its members, the Florida Coalition to End Homelessness (FCEH) encourages county and municipal leaders to work with their homeless continuums of care (CoCs). The CoC in your area has the training and experience to help follow best practices in ensuring emergency accommodations are safe, dignified, and appropriately targeted to households experiencing homelessness.

Strategies such as prevention, diversion, Rapid Rehousing, and Permanent Supportive Housing are being implemented successfully across Florida through the Homeless Continuums of Care and their partners. We are asking local governments to work with their local Homeless CoCs to reduce the impact of this new law on our neighbors who have no other option but to sleep on the street.

House Bill 1365 prohibits counties & municipalities from authorizing or otherwise allowing public camping or sleeping on public property without certification by the Department of Children and Families (DCF); authorizes counties to designate public property for such uses for a specified time period; requires counties to establish specific standards & procedures relating to such property; authorizes DCF to inspect such property and to issue notice; provides exception during specified emergencies and if the county is fiscally constrained

According to an analysis of the costs of these encampments, it will cost an average of \$23,910 per tent (including \$3,130 for the initial costs to set up) for one year. Alternatively, providing housing and supportive services will **end homelessness**. Permanent Housing with supportive services costs an average of \$18,530 per bed, per year.

There is not one community that has enough shelter The housing crisis affects everyone, especially those most at risk of being unhoused or already homeless, and each community must do what it can to help all the residents in their area. The state of Florida's 27 continuums of care have the expertise needed to help their communities.

Together, we can make homelessness in Florida rare, brief, and non-recurring.

Homeless Leadership Alliance of Pinellas Encourages Lawmakers to Consider Alternatives to Florida Senate Bill 1530 and House Bill 1365

Pinellas County, Florida - The Homeless Leadership Alliance of Pinellas (HLA) is urging Florida lawmakers to carefully consider the implications of Florida Senate Bill 1530 (SB 1530) and House Bill 1365 (HB 1365), which may negatively impact local governments, nonprofit organizations, and Floridians experiencing homelessness. As advocates for the most vulnerable members of our community, the HLA encourages legislators to explore alternative approaches that prioritize permanent housing solutions and transformative supportive services for individuals experiencing homelessness.

SB 1530 and HB 1365 propose measures to prohibit sleeping on public property, requiring certification from the Department of Children and Families (DCF) and introducing the possibility of legal action against local governments for noncompliance. However, these bills do not allocate adequate funding for shelter or vital supportive services. This places a strain on local governments and nonprofits, further limiting resources available to community members experiencing homelessness.

According to the latest report from the U.S. Department of Housing and Urban Development (HUD), Pinellas County, Florida, faces significant challenges related to homelessness, with high rates compared to similar communities nationwide. Over 2,100 individuals, including families, Veterans, seniors, and children, experience homelessness in our community on any given night. Penalizing these individuals and families for their involuntary circumstances only perpetuates cycles of poverty and marginalization, hindering critical efforts to address homelessness effectively.

The Homeless Leadership Alliance of Pinellas encourages lawmakers to explore alternatives that focus on funding and housing solutions that these individuals and families need, ensuring all members of our community are treated with compassion, dignity, and justice.
